## January's Event Features The Graham School

The Graham School, located at 3950 Indianola, a charter high school that has been in existence since 2000, offers a program unlike any other in central Ohio. Students spend time working and learning in their community along with their regular classroom work. This helps them to understand the relationship between their classroom subjects and the real world. The school is tuition-free

and open to anyone in grades nine through twelve.

As freshman, students go out in groups with their teachers to explore their community. Sophomores spend two days each week in internships, and three days in class, and are expected to document their internship experience. Juniors are encouraged to explore leadership styles and connect more with their community.

The senior class completes their state credits in January, and then spend the remaining term in two eight-week internships with a mentor, called Walkabout. To prepare for the internships, each student writes a background for their mentor and must fully document their experience.

The students at The Graham school receive life-long benefits from attending this unique program. The learn how to do a good job and what the consequences are in the real world if a good






