





2018 NMA Chair of the Board Comments

Thank you Lisa for your kind words of introduction. Taking the reins has been made easier by your leadership this year as Chairman. I know I speak for the entire Board of Directors in saying thank you for your commitment to NMA and the membership we serve.

My sincerest thank you and appreciation go out to my fellow Officers, Board Directors, Lifetime Directors and members. I am humbled and honored that you have entrusted me with this responsibility.

I must recognize the counsel and leadership advice of many Lifetime Directors but particularly my mentor from the Columbus Public Service Chapter, Bill Mahaffey, CM.

Finally, a special thank you goes to my family. They have been steadfast partners on this journey with me. Their encouragement and support have made it possible for me to continue my personal growth and professional development.

A few minutes ago, you had a chance to meet Shelly Menke, Michelle Lewis, CM and Scott Chesnut virtually taking their oath. As mentioned, Lisa Hart, CM will round out the 2018 leadership team as the Past Chair and my mentor this year. Our focus will be on the fundamental ideals of NMA. Key questions we will be exploring are NMA's continuous improvement and how to best position the organization in the future.

I would like to share with you a Chinese proverb that ties into our NMA core values for the upcoming year: When planning for a year, plant corn. When planning for a decade, plant trees. When planning for life, train and educate people.

There is a significant body of work regarding the analogy between organizational growth and leadership. Experts have debated growth and servant leadership as natural and positive processes. They are typically adaptive to both external and internal changing conditions.

Similarly, people, like plants are interrelated systems that require cultivation to encourage growth in new areas and develop new skills.

To bring this to a correlation with NMA: to remain healthy, we must receive nourishment or support for each other and provide a framework for members to change themselves and their Chapters in their changing company and community environments.

An example of this open growth concept is presented by the Banyan tree.

They have been called "trees that walk", because over time they grow step by step. What makes the Banyan unique is that a single tree may look like a whole grove of trees, for it has many trunks.

As a rule, it begins life in the top of another tree after birds drop a random seed. A sprout needs the collaborative support of a host tree for initial growth and provides a framework for the aerial roots.

Keeping in mind this new growth as the roots reach the ground from above strengthens it and creates opportunities for the formation of an independent support structure that eventually merges into the whole tree.

Along the way the Banyan roots are open to the air and potential damage, but eventually they reach the ground. This additional structure adds to the strength and stability of the ever increasing foundation. This continuous and seemingly random change allows the tree to spread and grow in unique and amazing ways.

Similarly, each NMA member has the ability to impact the health and vitality of our organization. The Chapters and its members are flexible, adapt to changing conditions, and yet continue to be resilient in the protection of core principles.

Maintaining this balance can be a significant challenge, but it is vital for both the Banyan tree and NMA.

As we embark on the vision for next year, the focus will be on "Growing NMA".

Currently we are conducting a national member growth initiative- "Each One Reach One – Lose None" that will continue through 2018. For those of you not familiar with the details, this is a team effort, with the overall goal of each Chapter increasing strength and membership.

Charles F. Kettering encouraged participation and growth in his Foremen's Club and stated:

"Like so many have said before me:

Get involved:

You won't ever regret it:

You will receive so much more than you give:

Go- pay it forward.

I challenge each of you to take to heart that "Each one Reach one; Lose none" will make a difference in the growth of NMA. Each of us is a proud member of the organization with a success story to tell.

This enthusiasm is contagious and when shared will plant the seed of an idea and a reason for a colleague or friend to become a part of NMA.

Again, I am honored to be here today and pleased to be sharing this moment with each of you.

Being a member of NMA continues to be a joy and a privilege that I am grateful for every day.

#### NMA Delegation Trip to the 2017 IMC Conference, Taipei, Taiwan October 31, 2017–November 8, 2017

The purpose of the trip was to explore the possibility of NMA and the International Management Council (IMC) of Taiwan joining efforts as sister organizations. Discussions centered on the previous history of both associations. Both NMA and IMC began in Ohio with similar missions, visions and goals of leadership development and providing training to employees. The IMC in America merged with and members became a part of NMA nearly seven years ago. This left the IMC of Taiwan behind because of differing governmental structures. Members continue to support sister agencies of YMCA, Lions and Rotary Clubs in their mission of service to the community in Taiwan.

NMA's organizational structure and the Professional Development programs were identified as a potential value for their IMC membership and as a tool to promote professional development for young professionals and entrepreneurs. In order to better understand the IMC, its mission, goals and diversity of membership as a whole, the delegation had the opportunity to visit six different chapters to learn about the business and culture in these distinct regions of Taiwan.

As officers of NMA, Kathy Spatz and Michelle Lewis, CM, were presented with this unique opportunity to attend the IMC Conference and represent NMA as Ambassadors.
