


#### FEBRUARY MEETING EVENT

This month we discussed Columbus Black History with Author Rita Fuller-Yates, CTA. Rita Fuller-Yates is a native of Columbus, an

acclaimed author, a Community Historian, Certified Tourism Ambassador and on the Columbus Historical Society Board of Trustees. Rita spoke to NMA members during our virtual February meeting about black history in Columbus, Ohio.



In 1803, Ohio was supposed to be a free state; however in 1804, The Black Code was started. Under this code, black people had to pay \$500, prove that they were free and have someone vouch for them. This was a systemic measure to hinder their freedom.





# NMA Family Scrapbook



NMA 2022-2023 Officer and Board Nominations will be taken from the floor at the next *MEMBER EVENT* on *WEDNESDAY*, *MARCH* 23<sup>RD</sup> for the following:

#### First and Second Vice President

Any candidate for these positions shall have been a member of the Chapter for one year before taking office, shall have been a director, officer and/or committee chairperson for one year before taking office. The Vice President (s) shall not be concurrent members of the Board of Directors.

The President will oversee the operation of the Chapter, conducting monthly Board meeting and Member Event (breakfast, lunch, dinner) with the help of other officers and committee members. In the event the President cannot attend, the First or Second Vice President will step in.

Nominations will not include the position of President as the 2021-2022 First Vice President (Melanie Mallet) will ascend to the Presidency. First and Second Vice are OPEN.

#### **Secretary/Treasurer**

Any candidate for these two positions shall have been a member of the Chapter for one year before taking office, and shall not be a concurrent member of the Board of Directors. After serving a full 12 month term, no officer, with the exception of the Secretary and/or Treasurer may succeed him/her in the same office.

The Secretary will schedule and attend board meetings, take and keep the notes of such meetings and assist in the paperwork process of new members. The Treasurer will maintain the accounting system for the Chapter, preparing and maintaining the budget, reporting monthly on expenses and all invoicing of membership to the entities involved.

#### **Board of Directors**

A director shall have been an officer and/or committee chairperson for one year before taking office as director and should not serve as a President, Vice President, Secretary or Treasurer, or standing committee chairperson during his/her term as director. Where any division does not have an eligible candidate for the Board of Directors, the Board may waive the eligibility requirements. Board members represent respective departments.

Also, we are also accepting nominations for Chapter Awards.

**Silver Knight Award** – This is the highest award our Chapter can bestow. Individual must be an executive who sets an example and inspires other Chapter members. It should be someone who consistently applies the principles of NMA's Code of Ethics to his/her daily work. Someone who has served as an outstanding influence in preserving our competitive enterprise system and contributes to a better understanding of the Association. This award is not limited to NMA members.

Columbus was founded after the war of 1812. In 1813, the prison system was established. Prisons were used for criminals but also for runaway slaves. They used these slaves for free labor. Blacks helped build cities.

Columbus has a lot of black history. Rita shared with us how the Underground Railroad traveled through Columbus. It is believed that 100,000 slaves came through but 40,000 stayed. John E Ward started the oldest African American Business, which is now E.E. Ward. Mr. Ward owned a farm that was in the location where Walnut Ridge High School now sits. Mr. Ward would transport slaves along with James Poindexter, who was a conductor of the Underground Railroad and had a barbershop in the downtown Columbus area.

Blacks had to build their communities. There was success in 1836 in the black community. However in 1836, the Columbus Lunatic Asylum was created. This asylum was located in the area where Columbus State Community College is now. These systems started to minimize the communities. Whites would deal with the black communities as long as it was small groups. The Great Migration caused conflicts because numbers started to grow. Whites later started redlining and building freeways. They put red dots on a map in black communities then started putting in freeway systems to break up the communities.

Blacks would fight in every war. The Revolutionary War had over 5,000 slaves. They fought in the Civil War on both sides, the Spanish War, WWI and WWII. They fought for the sake of gaining freedom. Some did feel honored to fight for the country and knew they could gain skills from joining the war. Soldiers became leaders. Harold Gibson was a black solider who fought in WWI and became a Columbus Police Officer.

Blacks continued progressing and striving for higher education. Rita told us about Jessie Francis Stephens Glover who was OSU's first black woman graduate. There is a lot more Columbus black history to learn. Rita challenges us on ways to get more information out and promote change. She has a book *Columbus Black History*. Her website is www.ritafuller-yates.com and she has a group *Columbus Black History* on Facebook, if you'd like to learn more about black history in Columbus. This meeting was very informative. Members were thankful for the presentation!
